- 1. Your deduction is allowed in full if you (and your spouse, if you are married) aren't covered by a retirement plan at work. If you file as single or head of household and are covered by a retirement plan at work, a full deduction is allowed if your modified AGI is ≤ \$68,000, a partial deduction if > \$68,000 but < \$78,000, and no deduction if ≥ \$78,000. If you are married and filing jointly and both you and your spouse are covered by a retirement plan at work, a full deduction is allowed if your modified AGI is ≤ \$109,000, a partial deduction if > \$109,000 but < \$129,000, and no deduction if ≥ \$129,000. If you are married and file jointly and are not covered by a retirement plan at work but your spouse is, a full deduction of your contribution is allowed if your modified AGI is ≤ \$204,000, a partial deduction if > \$204,000 but < \$214,000, and no deduction if ≥ \$214,000.
- 2. Taxpayers filing as single or head of household may contribute up to the limit if their modified AGI is < \$129,000, a reduced amount if ≥ \$129,000 but < \$144,000, and zero if ≥ \$144,000. Married taxpayers filing jointly may contribute up to the limit if their modified AGI is < \$204,000, a reduced amount if ≥ \$204,000 but < \$214,000, and zero if ≥ \$214,000.
